## Pre-Law Outreach Program

UC Irvine School of Law's Pre-Law Outreach Program ("POP") is sponsored by the **Orange County Bar Association Charitable Fund** and **Blueprint LSAT, Inc.** POP helps students from disadvantaged backgrounds understand the demands of law school, prepare for the law school application process, and be inspired to one day use their legal skills to give back to the community.

There is **NO CHARGE** for students admitted to POP, which will provide:

- A certificate for a **free LSAT Review course provided by Blueprint LSAT, Inc.**
- Detailed information on the law school admissions process
- Detailed information about the costs of law school and available financial aid
- Advice about excelling in law school from law students, faculty, and recent graduates
- Information about careers in law from practicing lawyers in many fields
- Limited scholarships for transportation and/or housing costs

### **ELIGIBILITY REQUIREMENTS: If you have questions, please see FAQ's on pg. 3-4**

- 1) You are a full time undergraduate student at an accredited college or university (this includes a community college);
- 2) You do not plan to submit any applications to law school until Fall 2018 or later;
- 3) You have a cumulative GPA of 3.0 or higher;
- 4) You are from a disadvantaged background, which may include **one** or more of the following factors (you only need to meet *one* of these requirements):
  - Family income within 200% of the federal poverty guidelines per <http://aspe.hhs.gov/poverty>
  - First generation college student
  - Limited familial exposure to post-college education and career opportunities
  - English is not the primary language in the home of origin
  - Overcoming educational hardships and challenges
- 5) You must attend all six programs 9am-2pm: June 24, July 1, July 8, July 15, July 22 & July 29. There are no exceptions for those studying abroad.

## Application Instructions:

### **REQUIRED DOCUMENTS:**

- 1) Complete the application in one of three ways:
  - a. Print out the form and hand-write your answers in blue or black ink, OR
  - b. Save the PDF document to your computer. Then fill out the PDF, and print it for submission. **If you cannot save the PDF to your computer, you will need to complete and then print the application in one session.**
  - c. Save the form as a PDF, if your computer will allow it, and email the application with all necessary documents.
- 2) Complete the requested essay.
- 3) Review the Checklist on page 17 for details on the following required documents:
  - a. Tax information
  - b. Financial aid letter
  - c. Transcripts

**OPTIONAL DOCUMENTS:** The following documents are not required, but are strongly recommended for those wishing to improve their chances of admission to POP.

- 1) Resume
- 2) Letter(s) of Recommendation, including the required waiver and forms.
- 3) Lodging and/or Transportation Scholarship Form, which provides a limited number of POP participants with reimbursement for travel expenses (gasoline, bus fare, or train fare), and the opportunity to stay on-campus at UCI each Friday night before the POP sessions.

## **Frequently Asked Questions**

**Q: What if I am no longer an undergraduate student? Can college graduates apply?**

A: Although you have already completed your undergraduate studies, you may apply to the program. However, priority will be given to current undergraduates. One goal of the program is to educate undergraduates about the law school application process and give them an opportunity to make changes to their GPA and extracurricular activities in order to be competitive for law school. Obviously you are not able to do that. However, if you are a very strong candidate you may still be able to participate in POP. It is impossible to know at this point how competitive the pool of applicants will be.

**Q: What if I do not have a 3.0 GPA?**

A: Those with less than a 3.0 GPA should not apply unless there is a serious life event that caused a significant drop in the applicant's GPA. If this is the case, you must submit an explanation of the life event, and know that priority will be given to students with a GPA of 3.1 or higher. The further your GPA is from a 3.0, the less likelihood you will have of being accepted. You should also provide all optional documentation, including letters of recommendation. **Please also be aware that if you truly want to attend law school, you should be striving to significantly improve your GPA. Having a lower GPA will make you much less competitive for top law schools, and will make it extremely difficult to get financial aid assistance.**

**Q: I am applying to law school this year (Fall), why am I strongly discouraged from applying?**

A: We strongly discourage applicants for POP that plan to apply to law school in 2017 (to attend in Fall 2018). It really is not in your best interest. By the time you complete POP and receive the certificate to attend an LSAT program, it will be the beginning of August. You will then have only a short time to take the course, study, and take the LSAT. Additionally, preparing your application for law school is a huge undertaking, and you should give yourself several months to prepare—more if you are a current student. Students that receive the most benefit from POP are those that have the opportunity to make changes in their academics and extra-curricular activities in order to make themselves more competitive for law school.

**Q: If I send in my application by E-mail, how do I submit my attachments with my application?**

A: You should submit as few attachments as possible. We prefer to receive one PDF with several documents rather than having to open and print multiple files. All attachments should be digital files (Word documents or PDF's)—not photos (.jpeg) of documents.

**Q: Are undocumented students allowed to participate in POP?**

A: Yes.

**Q: What year in college is best to attend POP?**

A: Rising juniors (current sophomores) get a lot out of the program. However, all undergraduates that are not applying for law school in Fall 2017 are welcome to apply. Those that have just completed their first or second year of undergrad will have more time to use the skills learned during POP to improve their competitiveness for law school.

**Q: Do I need to meet all of the qualifications to be considered a disadvantaged student?**

A: No. Only one of the factors is required, but you should mention all that apply to your situation.

**Q: What if I cannot attend one of the six Saturday sessions?**

A: We are sorry, but you should not apply unless you can and will attend all 6 sessions. Being absent or tardy will prevent you from receiving a certificate of completion, and you will not receive your certificate for a free LSAT course. If there is a significant life event that prevents attendance, you must contact the POP advisor, Grace Lee, immediately. If you know that you cannot attend one date, but feel that it should be excused, you should contact Grace Lee ([glee@law.uci.edu](mailto:glee@law.uci.edu)) for approval before applying. Please note that participation in a study abroad program is NOT grounds for missing a session.

**Q: What if neither my parents nor I have any tax documents to submit with the application?**

A: You may still apply, but you will need to submit tax information for any person that is providing financial support for you as well as a summary of the income of all members of the household, as requested in the application. If no tax information is available at all, you will need to **submit a letter explaining why**. We are trying to get a sense of your financial situation so try to provide any documentation that would assist with that determination, or at the very least an explanation of your household's financial situation.

**Q: I do not have access to a car, or I will not be in Southern California this summer, may I still travel to participate in POP?**

A: Yes, but you need to be very careful about your travel plans. A limited amount of travel funding is available to those that specifically apply for it, but the maximum is \$500 per participant. Thus, POP cannot reimburse you to fly back and forth multiple times during the summer to attend. Also, public transportation is very difficult to UC Irvine, and is basically impossible on Saturday mornings. Those travelling by public transportation will need to do so on Friday evening (arriving by 8pm), and stay in the dorms at UCI on Friday night. Those travelling long distances (i.e. from the Central Valley or Northern California), should be prepared to depart on Fridays by 12pm in order to safely arrive in Irvine by 8 p.m.

**REQUEST FOR TRANSPORTATION AND/OR HOUSING SCHOLARSHIP:**

The Orange County Bar Association Charitable Fund is able to fund limited scholarships for students in need of reimbursement for travel costs (gasoline, train fare, or bus fare)—not to exceed \$500 total (not per week), but the amount may be significantly less depending upon travel distance. Additional funds are available for some POP participants, who are travelling long distances or are using public transportation, to stay on-campus at UCI the Friday night before each Saturday morning program. Students staying on campus will be responsible for providing their own food.
