1. Please read these instructions, then fill out the application form on the next page.
2. UCI graduate students may take a law course at UCI School of Law if the course:
 - is not oversubscribed;
 - is related to your course of study and/or career goals;
 - is approved by your home department, the course instructor, and the School of Law Dean of Students.

You may not take more than 8 total units at UCI School of Law as part of your graduate study. See the School of Law Dean of Students for more details.
3. The School of Law semester calendar does not match that of the main campus quarter semester. You are responsible for knowing dates and deadlines as they relate to the School of Law.
4. Check with your home department to confirm that you may take a course at UCI School of Law, and to clarify how the units will be treated.
5. Obtain the signature approval of your department head or advisor.
6. Prior to the first class meeting, inform the instructor that you wish to take the class and obtain his/her signature approval. Alternatively, an email granting approval can be attached to your application form.
7. Bring or email the application with faculty signatures to the School of Law [Dean of Students](#) at EDU 1000.
8. If your application is approved, you will be enrolled in the course by the Law School Registrar. If you decide to drop the course you must notify the Law School Registrar.
9. You must take the course for the grade option (either CR/NC or a grade) selected by the law school. Most courses at the law school are offered for a grade. Refer to the UCI School of Law schedule of courses for exceptions.
10. You will need exam numbers to take UCI School of Law exams. You will be issued exam numbers and graded anonymously.
11. You must take the final exam on the published date, time and place. NO re-scheduled exams will be allowed.
12. Law grades are posted to transcripts about **six weeks after exams end**. This should be taken into consideration by graduating students prior to requesting enrollment authorization approval.
