Project denied: An affordable housing project slated for the northwest corner Beach Boulevard and Edinger Avenue was denied by City Council members on Monday after city staff reported the applicant wasn't abiding by development standards for the area. The 24-unit Casa Rincon project did not meet the city's criteria for open space and was not designed for integration of neighboring parcels, which is the goal of the Beach and Edinger Downtown Specific Plan. # **Mesa Water** denied copyright for pricey logo

District officials will appeal ruling that design isn't distinct enough.

Office rejected the logo design. If Mesa Water is unable to register a copyright, it could still use the logo on signs and other materials, UC Irvine law professor Dan Burk said, but officials could be hampered if they want to stop someone else from using it. Either way, the rejection is another setback to the branding effort, which saw its budget cut by more than \$200,000 after

sive spending. A design must have at least "a minimal degree of creativity" and it cannot be "familiar symbols or designs" to be granted copyright, the rejection letter said.

Stacy Taylor, the district's public and government affairs manager, said she plans to appeal and explain the "differences and nuances" of the logo. She said denials are common for initial copyright applications.

Not so, says Burk: "The threshold to get copyright is very low."

does not go into specifics, Burk believes the Copyright Office might be balking at the phrase "Mesa Water," which could be considered insufficiently original to obtain copyright.

The district's trademark application for the phrase, though, has been approved pending a public review process (it's no longer Mesa Consolidated Water District).

Typically, companies trademark logos instead of copyrighting them, but the United States Patent and Trademark Office has restrictions on public agencies, Burk explained.

In Mesa Water's case, the trademark is just for the words, and not for the logo.

One public relations consultant charged the district about \$30,000 to advise it on logo design. Other companies, including graphic designers, charged a total exceeding \$25,000.
