To this end, HBAIE and its sister charity, HBAIE Foundation, are proud to sponsor a \$1,000 scholarship for each of two deserving individuals.

One \$1,000 scholarship will be awarded to a student currently enrolled in law school or who will begin law school in fall 2025. A second \$1,000 scholarship will be awarded to a recent law school graduate who is not yet licensed (i.e., he or she graduated in 2024 or 2025 and is studying for the bar exam or recently took the bar exam and is awaiting results). These scholarships will be awarded based on merit, with significant consideration given to those applicants who demonstrate strong ties to the Inland Empire.
