Interested applicants must meet the following criteria:

1. Be currently enrolled as a **second, third, or fourth year law student** in good standing;
2. Have a **demonstrated connection to the San Joaquin Valley**, as well as a desire to practice law in Fresno, Madera, Merced, Kings, or Tulare County; and
3. **Be able to attend the annual Fresno County Young Lawyer Hopper Luncheon** on October 30, 2025, in Fresno, California.

Scholarship funds shall be used solely for educational purposes such as the costs of studying for or taking the Bar Examination, or in another manner appropriately related to the recipient’s preparation to being the practice of law. Scholarship funds will be awarded at the annual Fresno County Young Lawyer Hopper Luncheon on October 30, 2025.
