

## 2017-2018 BOUKAI FAMILY FOUNDATION SCHOLARSHIP

The Boukai Family Foundation is providing a scholarship to one UCI law student up to \$2,500 during the 2017-2018 academic year.

The values of family, faith, education and giving back to the community are closely held by the Boukai Family. This scholarship program was established to encourage current law students to build upon these values; advocate the importance of tolerance toward Islam and all forms of religions and faith traditions; and serve to strengthen opportunities for future generations in Muslim-American communities.

### **ELIGIBILITY REQUIREMENTS:**

- The student will demonstrate their understanding that the Boukai Family's philanthropy is based on family, faith, education, and giving back to the community.
- The student will demonstrate how their personal community activities encourage and support building bridges of understanding between the Muslim community and others throughout their legal education beyond.
- The student must be a U.S. Citizen enrolled for the full academic year.
- The student must be in good academic standing.
- The student will make every effort to attend the award reception hosted by the Boukai Family.
- The Boukai Family Foundation Scholarship is a merit-based scholarship but financial need may be considered. Financial need will be determined by UC Irvine School of Law Office of Student Financial Services
