

Summer 2015 Diversity Fellow Job Posting for 1Ls

First year law students with a commitment to diversity and an interest in gaining law firm and in-house experience are invited to apply for the Summer 2015 Diversity Fellowship Program in Los Angeles. This paid summer program is the result of a partnership between Fox Group Legal (“FGL”) and four major law firms: Alston & Bird, Greenberg Traurig, Hogan Lovells, and Morrison & Foerster. Candidates must be currently enrolled as first year students at an accredited law school. Candidates from Southern California law schools are particularly encouraged to apply.

During this 10-week summer program, the Fellows will spend their first five weeks in one of the participating law firms’ Los Angeles summer associate programs and their last five weeks at FGL. Fellows will be exposed to a variety of work assignments from different practice areas, including intellectual property, employment law and general litigation. At the firms, the Fellows may also be exposed to corporate transactional matters. The Fellows will be paid a stipend of no less than \$1,500 per week for the 10-week duration of the Fellowship. The program provides law students with the rare opportunity to spend their first-year summer working both in-house at an entertainment company and at a major law firm. The Fellowship also offers mentoring opportunities for law students early in their career.

Applicants should e-mail a single .pdf file containing a resume, cover letter, undergraduate transcript, all available law school grades or transcripts, and the contact information for one law school faculty member as a reference. The title of the .pdf file should be only the candidate’s name (last name, first name) and the .pdf file extension. In the cover letter, applicants should describe their experience with and commitment to diversity (including but not limited to diversity in the context of race, ethnicity, national origin, gender, sexual orientation and identity, religion and disability), and in particular, describe how their career will enhance diversity in the legal profession. Cover letters should be no more than 500 words. The cover letter should also indicate whether the candidate seeks consideration for a Fellowship at all four firms or only selected law firms.

The deadline to apply is **January 23, 2015**. Applications should be directed via e-mail to FGLFellowship@fox.com with the subject line “Diversity Fellowship Application.”
