

# Worker Center Lawyer Program UC Irvine School of Law February 23, 2013

A growing cadre of public interest lawyers at non-governmental organizations and law school clinics have provided legal support for workers' rights campaigns led by low-wage and immigrant labor activists. Although some of these campaigns are now collaborative efforts with established unions, the advocacy originated outside of the union movement amongst once-excluded workers.

Lawyers collaborating with worker centers bring a set of assumptions about law and legal action that depart from professional norms, even as compared with traditional worker-side employment and labor lawyers.
