Vasquez was in Washington on Thursday as part of an Orange County delegation attending a town hall meeting with the president on Latinos and the Affordable Care Act.

But Vasquez said he "couldn't return to Santa Ana if I didn't" talk about the troubling number of youth deportations.

Vasquez, who teaches world history and Mexican-American studies at Valley High School, said he was among a select few allowed to line up to meet the president during the town hall.

When he told the president about the number of deportations, he said the president asked him: "Why do you think it's so high?"

Vasquez said he replied: "It's a Republican county."

According to Vasquez, Obama's response was along the lines of: "There you go."

Obama then told him to say hello to his students, added Vasquez, who said he then asked the president to investigate the deportation

Orange County accounted for 43 percent of 697 detainer requests from the U.S. Immigration and Customs Enforcement issued to juvenile facilities in the state from October 2009 to February 2013, according to a UC Irvine School of Law report, titled "Second" Chances for All," released in December.

Vasquez said he handed a poem, "I Still Have a Dream," to an Obama aide. The poem was written by a

Vasquez said having a Santa Ana presence at the town hall was important because many of the city's residents speak Spanish at home.

Medina, with the Santa Ana Boys and Men of Color, said: "He (Obama) tried to calm some fears, but whether it's health - whatever issue it is - our community is concerned about the deportations."

The town hall will be broadcast at 7 tonight on Galavision and at 8 tonight on Telemundo. It will also air at 6 a.m. Sunday on Univision KMEX.

## O.C.'S FIFTH MEASLES **DIAGNOSIS MEANS EXPOSURE RISK AT** ST. JOSEPH HOSPITAL

A fifth Orange County resident has been diagnosed with measles, and public health officials on Friday warned that others may have been exposed earlier this week at St. Joseph Hospital in Orange.

Health Care Agency spokeswoman Nicole Stanfield said it's unknown how the unidentified adult contracted the illness. She said the patient's vaccination history is also uncertain.

The person was at the emergency department from 4:30 to 8:30 p.m. Sunday and from 7:30 p.m. to 5 a.m. Monday.

Officials said the risk of getting sick after brief encounters is low, but as a precaution, those who were at St. Joseph at the same time should review whether they received the MMR vaccine for measles, mumps and rubella. If not, they should discuss getting vaccinated with a

medical provider.

They should also watch for symptoms, which can develop between seven and 21 days after exposure, starting with a fever, cough and runny nose. Two to four days later, a red, blotchy rash develops, usually starting around the ears and hairline and then moving to the face, torso and limbs.

Anyone with symptoms should immediately contact a doctor.

In December, the first local measles case was diagnosed; three more followed in January and February. Two of the patients had traveled to Asia. In a typical year, Orange County sees no more than one case.

State officials have also seen a surge in cases and have noted that about half were children and young adults who were intentionally not vaccinated.

## Blind man falls, lands just out of train's path

LOS ANGELES • A blind man walked off the edge of a subway platform and bounced off one of the rails below, landing in a tiny alcove in the track bed just wide enough to keep him from being struck by an approaching train, a transit official who saw video of the incident said Friday.

If the 47-year-old man had bounced in the other direction he would have gone into the path of the 90,000-pound train, said Los Angeles County Metropolitan Transportation

Authority spokesman Paul Gonzales.

"I have used the word miracle before and I still can't think of a different word," Gonzales said after viewing surveillance video of Thursday's fall at a metro station in Los Angeles' Koreatown neighborhood. "He could have fallen a different way and it would have ended a different way."

Both Fire Department and Metro officials declined to release the man's name, citing medical privacy laws, and Gonzales said the transit agency would not release the vid-

### **5 CONVICTED BELL LEADERS SUE EX-CITY ATTORNEY**

Five former leaders of the city of Bell who were convicted in a municipal fraud scandal sued their former city attorney Friday, saving he led them to believe they were doing nothing wrong when they accepted six-figure salaries.

The former members of the Bell City Council were convicted last year of stealing taxpayer money and using it to pay themselves huge salaries to operate the small, blue-collar suburb where more than a quarter of residents live below the poverty line.

In their lawsuit, filed in Los Angeles County Superior Court, the five accused the firm Best Best & Krieger and one of its former partners, Edward W. Lee, of failing to "exercise proper care and skill" when it came to advising them on such legal matters as forming the recycling board and several other municipal agencies from which they collected salaries.

#### Bill would ban orca shows in state

A lawmaker wants to ban SeaWorld from using killer whales in its San Diego shows.

Assemblyman Richard Bloom, who unveiled the bill Friday, says orcas are too large and intelligent to be confined in small tanks for their entire lives. His measure also would ban captive breeding and prohibit the

import and export of orcas. SeaWorld spokesman Dave Koontz says the company hasn't seen Bloom's legislation and can't comment on it.

#### L.A. officer killed in car crash

A veteran Los Angeles police officer was killed and his rookie partner was critically injured Friday when their patrol car collided with a big rig on a residential street. The truck driver also was injured.

The Hollywood division officers were responding to a call of unknown trouble when the "catastrophic" collision occurred, Los Angeles Police Chief Charlie Beck said.

The county coroner's office identified the slain officer as Nicholas Choung Lee, 40. Beck said he was a 10-year veteran and a highly respected training offi-

#### **Husband arrested** in 1989 murder

Two brothers in Northern California face murder charges in the case of a woman found strangled in her car nearly 25 years ago,

authorities said Friday. David Zimmer, 66, of Half Moon Bay, was arrested Friday in the slaying of his estranged wife, Cathy Zimmer. Her body was found wrapped in a patchwork quilt in the backseat of her Chrysler New Yorker in a parking lot at San Jose International Airport in 1989, the Santa Clara County District Attorney's Office said.

David Zimmer's brother, Robert Zimmer, 69, of Santa Clara, was arrested last week on similar charges.

#### CrossFit accused of discrimination

A transgender woman in Northern California has sued the company behind the popular CrossFit workouts for refusing to let her compete in the female division of its annual fitness competitions.

The lawsuit brought Thursday by Chloie Jonsson, 34, accuses CrossFit Inc. of violating her rights under a California law that prohibits discrimination on the basis of gender identity.

Jonsson's complaint says she was born male but has been living as a woman since she was a teenager and underwent sex reassignment surgery eight years ago. The surgery, coupled with the female hormones she takes, satisfied the state's requirements for her to be recognized as female on her birth certificate and other official documents.

"They said she has an advantage over other women because of the sex she was born with, and that is completely untrue, scientifically," her lawyer, Waukeen McCoy said, noting that the


The Ventura County Star says authorities were inundated with calls late Thursday morning about the man. Several hours later, heavy equipment was used to bring him down.
