Speaker Bios

Samrah Mahmoud is a counsel in Crowell & Moring's Orange County office and is a member of the firm's Litigation Group. Her practice focuses on complex commercial litigation and antitrust recovery litigation. Samrah has significant experience litigating in both federal and state court, particularly in Southern California. Before joining Crowell & Moring, Samrah clerked for the Honorable Josephine L. Staton of the United States District Court for the Central District of California. Samrah graduated *summa cum laude* from the University of California, Irvine School of Law. She was a member of the school's inaugural class and a senior editor of the *UC Irvine Law Review*. Samrah graduated *summa cum laude* from Chapman University with a B.A. in psychology. In addition to her practice, Samrah recently taught Antitrust Law at UC Irvine School of Law.

Erika Pinheiro is the Policy and Technology Director at Al Otro Lado. She earned both a J.D. and M.P.P. from Georgetown University, and is trained in econometric analysis of immigration policy. For several years, Ms. Pinheiro administered federally-funded, high-volume immigration legal access programs in county jails and immigration detention facilities housing adults and children. She helped create an all-volunteer Legal Orientation Program for immigration detainees housed in Orange County jails. Ms. Pinheiro also managed legal orientation programs for unaccompanied children and their sponsors. Ms. Pinheiro has conducted trainings on DACA/DAPA for public agencies and community bases organizations, and regularly offers technical assistance to LA County in crafting pro-immigrant policies, and to public agencies servicing noncitizens. She has represented unaccompanied minors since 2010, and administered CARECEN's Refugee Family Program, which offered pro se assistance to recently-arrived families facing removal proceedings in Los Angeles. Ms. Pinheiro advocates tirelessly to protect immigrants' due process rights before U.S. courts and at the border.
