Speaker Bios

Douglas M. DeGrave is a member of the National Board of Directors of the American Board of Trial Attorneys, and one of its Trustees. He is the founding partner of Poliquin & DeGrave, LLP, where he specializes in the defense of personal and catastrophic injury cases, wrongful death, trust and bus accidents, insurance litigation, insurance bad faith claims, and construction cases. He is one of approximately 100 lawyers certified as a civil trial specialist in California. Mr. DeGrave has also served as an arbitrator and mediator, privately and for the courts. For more than a decade, Mr. DeGrave has been named by *L.A. Magazine* as one of Southern California's Super Lawyers. In 2018 he was listed as one of the "Top 50 Lawyers in Orange County" and "Top 100 Defense Litigators in California." Mr. DeGrave earned his undergraduate degree from the University of Hawaii while serving in the U.S. Army. After his military service, he earned a B.A. degree in Political Science from California State University at Long Beach, and his J.D. degree from Loyola Law School.

Michael P. Maguire is the current National President of the American Board of Trial Attorneys. Prior to entering private practice, Mr. Maguire served as a deputy district attorney in Orange County, where he helped organize a task force to prosecute child molestation and sexual assault cases, and later gang homicides. After the D.A.'s Office he tried personal injury cases and became a founding partner in Nyman, John & Maguire. Mr. Maguire is now the Managing Attorney of State Farm's staff counsel in Costa Mesa, where he oversees 47 employees, including 19 staff attorneys. In addition to his leadership in ABOTA, Mr. Maguire is active in the Orange County Bar Foundation, which works primarily with at-risk youth providing education, services and programs designed to keep kids out of jail, in school, out of gangs, and help them make healthy life choices. He earned his B.A. degree at UCI, and his J.D. at Loyola Law School.

Alexandra Natapoff is a Chancellor's Professor of Law at UC Irvine School of Law. Prior to her teaching career, Professor Natapoff served as an Assistant Federal Public Defender in Baltimore, Maryland. Her scholarship has won numerous awards, including a 2016 Guggenheim Fellowship. Her new book, *Punishment Without Crime: How Our Massive Misdemeanor System Traps the Innocent and Makes America More Unequal*, was selected by Publishers Weekly as a Best Book of 2018. Professor Natapoff is also the author of *Snitching: Criminal Informants and the Erosion of American Justice*, which won the ABA Silver Gavel Award Honorable Mention for Books; her original work on criminal informants has made her a nationally-recognized expert. Prof. Natapoff graduated *cum laude* from Yale University, and earned her J.D. degree with Distinction from Stanford Law School. After law school she clerked for the Honorable David S. Tatel, U.S. Court of Appeals, District of Columbia, and for the Honorable Paul L. Friedman, U.S. District Court, Washington, D.C.

Mark P. Robinson, Jr. is the founder, senior partner, and sole shareholder of Robinson Calcagnie, Inc. Mr. Robinson has established a prominent legal practice devoted to consumer safety and has worked on thousands of products liability cases, including the landmark Ford

Pinto case, where a jury awarded \$128 million in compensatory and punitive damages. The verdict was recognized by the Association of Trial Lawyers of America as one of the 10 most significant civil trials of the past millennium. Mr. Robinson served as the National President of the American Board of Trial Attorneys in 2014. For many years, he has been listed in *The Best Lawyers in America*®, a peer-reviewed survey listing outstanding attorneys throughout the United States, and has consistently been named as one of the Top 100 Lawyers in California. He has received numerous awards throughout his illustrious career. Mr. Robinson is a member of the UCI Law Board of Visitors, and the Law School’s Moot Court Room is named for him. He is a graduate of Stanford University and earned his J.D. degree *cum laude* from Loyola Law School.

Brooke Weitzman graduated from UCI Law in 2014 with Pro Bono High Honors after completing an astonishing 429.75 hours of pro bono service. As a law student, Ms. Weitzman planned symposia on “Opposing the Criminalization of Homelessness: Building a Human Rights Framework” and “Prisoner’s Access to Justice: Exploring Legal, Medical, Mental Health, and Education Rights.” After graduation, she co-founded the Elder Law and Disability Rights Center (ELDR), where she has been in the forefront of successful litigation on behalf of Orange County’s homeless residents. Brooke has also provided legal services to veterans as an Equal Justice Works AmeriCorps Legal Fellow, where she worked to ensure access to justice, prevent homelessness, increase employment, and protect the rights of our veterans. She earned her undergraduate degree at Northwestern University, and is the current Secretary of the UCI Law Alumni Association.
