Requesting a recording

If the instructor does not allow recordings and you wish to inform your professor of the reason for your absence, please email the instructor directly. If you prefer to keep the reason confidential but seek an excused absence, please email Dean Schroeder.

NOTE: To guarantee that an approved recording request actually records your class, please submit your request at least one business day in advance of the requested recording time. If the request and approval comes in after that time frame, we cannot guarantee that the recording will take place.
